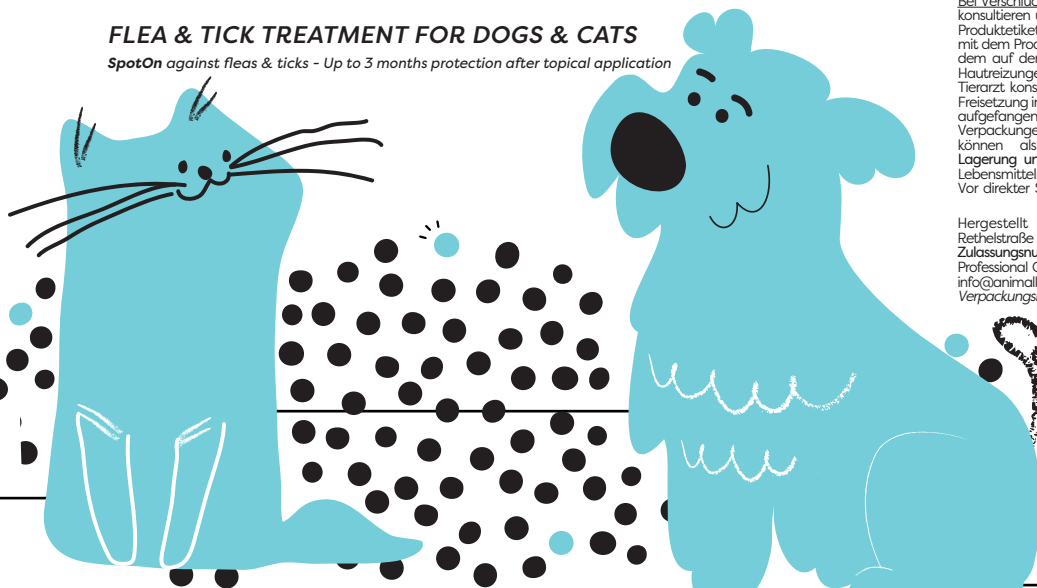

## SECTION 4: First aid measures

### 4.1. Description of first aid measures

**General information:** Immediately remove the injured person from the source of danger. Remove contaminated clothing and footwear immediately. Do not give liquids to drink and do not induce vomiting for an unconscious or convulsing victim.

**In case of inhalation:** move the injured person to fresh air, keep them warm and calm.

**In case of skin contact:** after use or accidental skin contact, wash hands or other exposed skin surface thoroughly with soap and water.

**In case of eye contact:** rinse eyes with running water while pulling the eyelids apart and constantly moving the eyeball. Remove the contact lenses, if present and easy to do so, then continue rinsing. If symptoms persist, consult a specialist.

**4.2. Most important symptoms and effects, both acute and delayed:** significant effect, critical hazard not expected.

**4.3. Indication of any immediate medical attention and special treatment needed:** not relevant.

**Note to physician:** treatment based on observed symptoms is required. In case of ingestion of large quantities, consult a toxicologist immediately.

## SECTION 5: Firefighting measures

### 5.1. Extinguishing media

**5.1.1 Suitable extinguishing media:** standard extinguishing media: alcohol-resistant foam, carbon dioxide, dry extinguishing media, water spray. It is advised to select the extinguishing media based on the combustible materials in the environment.
